**THE COPYRIGHT, DESIGNS AND PATENTS ACT 1988**

Under section 43(2) of this act we are allowed, by law, to supply ONE copy per person of any document in copyright, which is to be used for research or private study ONLY. It is for this reason that we ask you to sign a copyright declaration.

Because of the abolition of perpetual copyright by the Act, a transitional period was introduced which means that **most** unpublished documents (i.e., most archives), **no matter of what age**, remain in copyright UNTIL AT LEAST 31 December 2039.
